

### Introduction

There are two ways to participate in Promptings: as a customer or a Gratitude Consultant. As a customer, you can refer other customers and earn credit that can be applied to product purchases. As part of our Consultant program, you have several ways to utilize the Promptings system to generate income for yourself. There are multiple ways to earn commissions and bonuses through our compensation plan; this document will detail them. You may participate in the Consultant program for either a monthly fee of \$14 or an annual fee of \$99, which includes all your business-building tools.

*All dollar amounts are listed in US Dollars.*

### How do I make money with Promptings?

You become your own boss as an independent Promptings Gratitude Consultant. You make money with Promptings by gathering other customers and Gratitude Consultants who purchase the products and services from the Promptings product lines to meet their needs. Essentially, they use our Promptings products and services in their businesses and personal lives.

There are several ways of earning an income with Promptings. You get paid through earning commissions and bonuses for different actions throughout your downline (or Team).

**General Terms to Know** As you learn how to make money with Promptings, a few network marketing terms will help you understand how you earn income.

**Downline** The organization below an individual Gratitude Consultant consisting of levels of other Gratitude Consultants and customers either sponsored directly by the individual, or by the other Gratitude Consultants within the direct line of sponsorship or referred by customers in the organization. This means those you directly sponsor as Gratitude Consultants and customers, and so on downward..

**Upline** The Gratitude Consultant or Gratitude Consultants above a particular Gratitude Consultant in a direct line of sponsorship up to the company (Promptings). It is the line of sponsors that links any specific Gratitude Consultant to the company. This means that just as you have a downline, you also have an upline.

**Leg** Each person you personally sponsor is considered a leg regardless if they are a customer or Gratitude Consultant. All customers enrolled by a specific front-line Gratitude Consultant or customer and all of their downline Gratitude Consultants and customers count as a part of that leg as well. Each leg may contain any number of Gratitude Consultants and customers underneath that Gratitude Consultant, in their downline organization

### How do I earn commissions/bonuses?

Each commission and bonus type has different qualification requirements. To be eligible to earn all available commissions and bonuses, a Gratitude Consultant is required to be rank qualified at their highest achieved rank. You begin your journey as a Gratitude Consultant and your first goal is to rank advance to Silver.

## What is Qualifying Volume?

Qualifying Volume (QV) is earned on purchases made by Gratitude Consultants and their direct customers. Qualifying Volume is used to qualify for your rank promotions of Silver and above; and to maintain your Silver and above Team Commissions, Team Leadership Commissions, and Override Bonus pay. Qualifying Volume is assigned to subscriptions, specific products, and packages. Qualifying Volumes for the Promptings current product and service offering can be found below in the Promptings Gratitude Product Offering with Commission Details section of this document..

## What is Commissionable Volume?

Commissionable Volume (CV) is earned on purchases made by Gratitude Consultants and their direct customers. Commissionable Volume is used for commissions paid on Levels 2+. Commissionable Volume is assigned to subscriptions and specific products. Commissionable Volumes for the Promptings current products and services can be found below in the Promptings Gratitude Product Offering with Commission Details section of this document.

## How do I qualify for commissions/bonuses, rank advancements and coded statuses?

Your qualifications for commissions/bonuses and rank advancements are based on various calculations of your and your downline's actions. Here are the things you need to know about qualifying:

1. You must be active.
  - a. To be considered active, you must be current on your Gratitude Consultant renewal fee(s).
2. To qualify for commissions or bonuses you must meet all qualifications for commission or bonus within the qualifying period.
3. To qualify for a rank you must be qualified at each rank individually below that rank.

## What does it mean to be active?

Promptings Pro Gratitude Consultant:

You are current by paying your \$14 monthly Gratitude Consultant fee in the last 30 days -OR- \$99 annual Promptings Gratitude Consultant fee in the last year.

SendOutCards Gratitude Consultant:

You are current on your \$79 annual SendOutCards renewal fee in the last 12 months.

*SendOutCards Gratitude Consultants are only eligible to earn on SendOutCards Product sales. Any bundled products or services that contain multiple product lines are not considered a SendOutCards product. The Bonus Pay program is not available for SendOutCards consultants. This Gratitude Consultant program is grandfathered for consultants who were part of the company before January 31, 2021, and have not let their consultant renewal lapse. Starting September 1, 2024, all SendOutCards Consultants will be converted to Promptings Gratitude Consultants at their next annual renewal date.*

## What are the types of commissions and bonuses I can earn?

We will briefly outline them here before going into greater detail in a later section.

### Retail Sales

Retail sales are items that you have in your personal inventory that you sell directly to an individual. Promptings recommends that all sales be made from the website to properly track sales for commissions and bonuses. Any sales made in this manner by a Gratitude Consultant require that a sales receipt be provided to the customer with the terms of the sale and instructions

for return and refund.

### Consultant Direct Commissions (Daily Commission)

When a Gratitude Consultant sells a product to a customer or personally sponsored Gratitude Consultant, they will receive a commission, which is currently between 10% and 20% of the sales amount or a set commission amount for specific products, subscriptions and packages. Consultant Direct Commission amounts for the Promptings current product offering can be found below in the Promptings Gratitude Product Offering with Commission Details section of this document. The Consultant Direct Commissions will be paid to any active Gratitude Consultant. This means they are current on their renewal and not in violation of any policies and procedures.

### Override Bonus Pay (Daily Bonus)

Override Bonus Pay is linked to your active paid as rank, at the time the order is placed, and can be earned on the purchases of customers and Gratitude Consultants in your downline when you are the first upline Gratitude Consultant paid as a Gratitude Consultant, Silver, Gold, or Platinum. Override Bonus Pay amounts can be found below in the Promptings Gratitude Product Offering with Commission Details section of this document.

### Team Commission (Monthly Commission)

Team Commissionable Volume is earned by Gratitude Consultants who are ranked Silver, Gold, Platinum, or above. A team commission is paid based on a percentage of the Commissionable Volume accumulated during the month at the appropriate level.

Team Commissionable Volume (CV) is paid out based on the following chart:

Paid As Rank	Levels Summed	% of CV
Silver	Level 2 only	10.3%
Gold	Level 2 & 3 (must qualify as Silver)	11.5%
Platinum or higher	Level 2, 3 & 4 (must qualify as Star 2 & 3)	13.4%

### Team Leadership Commission (Monthly Commission)

Team Leadership Commissionable Volume is earned by Gratitude Consultants ranked as Diamond and Eagle. A team leadership commission is paid based on a percentage of the Commissionable Volume accumulated during the month at the appropriate level.

Team Leadership Commissionable Volume (CV) is paid out based on the following chart:

Paid As Rank	% of CV for Primary Leadership Group	% of CV for Secondary Leadership Group
Diamond	4%	2%
Eagle	6.2%	3.1%

For Diamond, payouts are based on your primary and secondary leadership groups which start with Level 5 in your genealogy (excluding the tertiary and beyond leadership groups of any Gratitude Consultant of the same or higher Lifetime rank during the previous monthly commission period).

For Eagle, payouts are based on your primary and secondary leadership group which starts with Level 5 in your genealogy (excluding the tertiary and beyond leadership groups of any Gratitude Consultant of the same Lifetime rank during the previous monthly commission period).

**Note:** Your primary team leadership group is made of all of the Commissionable Volume in your Levels 5 to infinity, as long as you do not have a downline Gratitude Consultant that is the same team leadership rank as you or higher. In the case where you have a Gratitude Consultant at the same team leadership rank as you or higher, their Team Leadership Commissionable Volume (starting at their Level 5+) is considered your secondary team leadership group. If another Gratitude Consultant downline from them is your same team leadership rank or higher, their Team Leadership Commissionable Volume (starting at their Level 5+) becomes your tertiary team leadership group. And so on.

## Customer Referral Program

To participate in the Customer Referral Program, a customer must opt-in and agree to the Promptings Customer Terms and Conditions. When they refer anyone on their first level, they will receive a \$50 referral credit to be used on Promptings products for every \$240 in Commissionable Volume generated. This is calculated and added to customer accounts as part of the monthly bonus run.

For Gratitude Consultants, when your customer refers another user (customer or Gratitude Consultant), the new user is on your Level 2. If that user refers another user, then that user would be on your Level 3, and so on. You would earn Commissionable Volume on these new users, on the level of your organization they are on.

For products and services with Override Bonus Pay, the Gratitude Consultant commission will be paid to the first upline Gratitude Consultant and is not included in the Customer Referral Program. For example, if a customer on your Level 2, is sponsored by a Customer (your Level 1), then the Gratitude Consultant Override Bonus for that specific product (i.e. Solopreneur Package) would be paid to you as the first upline Gratitude Consultant.

A new first-month subscription is defined as a brand-new subscription purchase. Any add-ons, upgrades, or downgrades to an existing subscription will be treated as ongoing subscriptions for compensation purposes.

Incremental Sales come from the sales of additional cards and gifts (including Bella Cadeaux and Blue 42 products). This chart shows the Consultant Direct Commission payout percentage along with CV and QV for these incremental product sales.

Please note: Gift Cards, Books, Gratitude Consultant Tools, Promptings to Prosperity Spouse/ Partner or Repeat Attendee Tickets, and Final Sales products do not pay Consultant Direct Commissions or have a CV or QV attached unless stated otherwise..

### What is a bonus period or qualification period?

All bonus and qualification periods are based on the U.S. Eastern Time Zone. The bonus period for monthly commissions and bonuses is the calendar month. The qualification period is the timeframe used to determine if a Gratitude Consultant is qualified to be paid the bonus and/or commission that is being evaluated for that bonus period.

The bonus period the daily commission and bonuses are as follows:

Qualification Day	Day Commissions Released
Monday	Thursday
Tuesday	Friday
Wednesday	Monday (of the following week)
Thursday	Tuesday (of the following)
Friday, Saturday & Sunday	Wednesday (of the following week)

Monthly bonuses and commissions will be paid on the 10th of the following month. If the 10th falls on a Saturday, the bonus will be paid on Friday. If the 10th falls on Sunday it will be paid on Monday.

## Advancement

Upon joining Promptings, each Gratitude Consultant starts at the rank of Gratitude Consultant. Advancing through the ranks takes place when you meet the requirements to advance to the next given rank. You must achieve all of the requirements of your current rank before you can advance to the next rank.

## What are the ranks in Promptings and how do I advance from one rank to the next?

Gratitude Consultants must be active to be eligible to rank advance. To be paid at your highest achieved rank, you must meet the necessary rank qualifications for that rank each month. Once you have achieved a rank the first time, that becomes your Lifetime Rank and you will keep that title unless demoted.

For the first three calendar months at your new Lifetime rank, you will automatically qualify for all commissions at that rank. After your three-month grace period, If you qualify at a lower rank in the future, your Paid As rank will be the rank you qualified at for that month, but your Lifetime Rank will not change.

## Silver

Silver is our first rank advancement. The Silver requirements in your first 60 days as a Gratitude Consultant are:

To be current on your Gratitude Consultant fee

- Have at least 500 in Qualifying Volume between your personal purchases and purchases on your Level 1.
- Have 1,500 in Qualifying Volume in up to your first 3 levels.
- Your personal purchases can contribute no more than 500 QV of the total.

After your first 60 days as a Gratitude Consultant, the Silver requirements are:

- To be current on your Gratitude Consultant fee
- Have at least 500 in Qualifying Volume between your personal purchases and purchases on your Level 1 in a calendar month.
- Have 1,500 in Qualifying Volume in up to your first 3 levels in the same calendar month.
- Your personal purchases can contribute no more than 500 QV of the total.

## Gold

To become a Gold, the requirements are:

- Meet the requirements of Silver
- Have 4,500 in Qualifying Volume in up to your first 3 levels in a calendar month.
  - Your personal purchases can contribute no more than 500 QV of the total.
  - No more than 2,250 in Qualifying Volume can come from any one leg.

## Platinum

To become a Platinum, the requirements are:

- Meet the requirements of Gold
- Have 13,500 in Qualifying Volume in up to your first 4 levels in a calendar month.
  - Your personal purchases can contribute no more than 500 QV of the total.
  - No more than 6,750 in Qualifying Volume can come from any one leg.
- Meet one of the two following criteria:
  - Personally promoted a Silver in the last 6 months, as long as the promotion date is dated later than December 1, 2023.
  - Attended Promptings to Prosperity in the last 12 months.

## Diamond

To become a Diamond the requirements are:

- Meet the requirements of a Platinum
- Have 40,500 in Qualifying Volume in up to your first 4 levels and from your primary and secondary leadership groups in one calendar month
  - Your personal purchases can contribute no more than 500 QV of the total.
  - No more than 20,250 in Qualifying Volume can come from any one leg.

## Eagle

To become an Eagle, the requirements are:

- Meet the requirements of a Diamond
- Have 121,500 in Qualifying Volume in up to your first 4 levels and from your primary and secondary leadership groups in one calendar month
  - Your personal purchases can contribute no more than 500 QV of the total.
  - No more than 60,750 in Qualifying Volume can come from any one leg.

**Note for Diamond and Eagle:** Your primary team leadership group is made up of all of the Volume (both Qualifying and Commissionable) in your Levels 5 to infinity, as long as you do not have a downline Gratitude Consultant that is the same team leadership rank as you are or higher. In the case where you have a Gratitude Consultant at the same team leadership rank as you or higher, their Team Leadership Volume (both Qualifying and Commissionable starting at their Level 5+) is considered your secondary team leadership group. If another Gratitude Consultant downline from them is your same team leadership rank or higher, their Team Leadership Volume (both Qualifying and Commissionable starting at their Level 5+) becomes your tertiary team leadership group. And so on.

Note: Rank advancements may take up to 24 hours to process and will be reflected in your Revolution Office or on your dashboard.
